**2**, Hydraulic brakes maybe fitted to either the front axle or rear lay shaft, not both, for the Fg Mini Class

**Reason for proposal-** Brakes are a known problem this opens it up for the racer to make a choice if they upgrade and can choose Either front OR layshaft (rear), but not both to keep costs down

**11,** Protest Procedures

• Protests must be received by the BRCA Steward in writing with a fee of £20.00.

This fee is refunded if the protest is upheld.

- No protests will be accepted after prize giving ceremony.
- If any protest is made against a competitor, then that protest must be held in the

full knowledge of that competitor. The accused competitor will be consulted and

allowed to defend his actions before a decision is reached.

However I was shown them in a section hand book (which isn't published and available for all)??? Anyway the ones I was shown were open to meaning several different things, so I have lifted the protest procedure straight from the 12th section.

All protests must be made in writing to the race director, together with a £10.00 deposit. If the protest is upheld, this money will be reimbursed.

The protest period of 30 minutes shall commence when the **results in question** are published on the results board. Protests regarding the legality of cars must be made in writing, together with the fee, to the race director.

**12,** To run the GTS with the touring cars, rename the two classes National and Super National and award points separately for each class. Top 3 of the National class move up to Super National, lowest 5 of the Super National can return to National the following year.

**13,** Introduce an Open 4wd class and to differentiate between the class from the Mini class, they must use a different body shell and can be 510mm or 535mm wheel base. Top 3 of the Mini class move up to the Open 4wd class, lowest 5 of the Open 4wd class can return to Mini class the following year. Also the top 3 drivers in Mini class to move up to open class, bottom 5 in open can move back to standard.

**Reason for proposal-** To keep the Mini 4wd class as it is now to encourage new drivers and keep costs down. Stops new drivers feeling intimidated.

14, Deliberate track cutting will be penalised by removal of that lap.

**Reason for proposal-** The current rule book penalties doesn't adequately cover when I driver cuts off a large piece of track. The penalty is not aimed at a genuine mistake and cutting a single corner.
