## **Description**\Justification

Each round of the national series will have a selected tyre set. chosen by the committee with discussions with importers / distributors.

for example round 1, brand X has been chosen with Shore Y/Z for Front & Rear.

The driver is responsible for sourcing their own tyres before the event, they must remain in original sealed packaging with part number intact. These packets are checked when submitted to tech on the Saturday/Sunday morning 8am-8.30am, the driver is given a ticket for each set handed in. All packets are placed into the same box to from which the tyre controller will supply from. The driver is to supply a bag to which the tyres will be placed in after the run, each heat will have a box dedicated for the bags, so drivers can choose to re use tyres.
