Minutes from 2017 AGM:

Chairman's report:

Acting Chairman gave a brief report on the season's events and successes.

Treasurer's report:

Treasurer reported that the section finances are good, report was distributed amongst the attendees and accepted. 100 drivers registered for 2018 season, which is slightly down from 2017 however meeting attendance figures actually increased.

It was discussed and agreed by all that for the 2019 season juniors and drivers aged 65 and over would not have to pay for their race number.

BRCA Section Award – Paul Dexter

Proposals:

1. New rule "Extra marshalls to be placed in the middle of the track."

Proposed by Nikki Betts, Seconded by Steve Gould.

Proposal was discussed at length and the BRCA general rules referenced that it is up to the affiliated club running the meetings to designate marshal points that are safe. Several attendees stated they would not feel safe positioned within the circuit, whereas others saw it as a good option.

The rule proposal was voted on and rejected, however it was agreed that any club wishing to trial and introduce these alternative marshal positions could do so with volunteer marshals and as long as safety is not compromised.

2. New rule "Champion of Champions meeting to be held at Leicester every year on the weekend of the Main BRCA AGM i.e. Section AGM on Saturday Racing on Sunday".

Proposed by Nikki Betts, Seconded by Steve Gould.

It was noted that the introduction of this proposal would directly conflict with a BRCA Rule "No BRCA race meetings can be run on the day of the BRCA AGM". Proposal was withdrawn by the Seconder (proposer not present). 3. New rule "The height of the Body from the top of the bumper rail is limited to 8.5cm minimum and 13cm maximum."

Proposed by Steve Gould, Seconded by Nikki Betts.

General opinion from the discussion was that the current rule is already suitable and the proposal was not required. The proposal was voted on and rejected.

4. New rule "With the exception of World's and Euro's any driver who is willing to travel abroad to race should be allowed to bring their scores back to be awarded grading points".

Proposed by Steve Gould , Seconded by Nikki Betts.

The Grading Officer explained that the Stock Cars section is part of the BRCA – a UK based organisation – and all race meetings are run by affiliated BRCA recognised clubs. Meetings held outside the UK/BRCA are not sanctioned and therefore not eligible to enter BRCA meetings/championships. Proposal was withdrawn by proposer.

5. New Rule "Booking in for English and British competitions should be the same as World's and Euro's i.e. a month before. Set entry fee to be paid on booking, late bookings occur an extra charge "

Proposed by Nikki Betts , Seconded by Steve Gould.

A very lengthy discussion was held on this proposal. Secretary noted the following -Proposal conflicts with Stock cars section Procedural Rule 7 Race fees "Major/ Series All meetings will be open to all section members with entries being taken only on the day of the event".

BRCA Treasurer Jim Spencer addressed the room and described the BRCA's position on event pre booking and online payment, which is as follows: if a meeting requires a booking-in form then it *has* to be done on the BRCA website. Payment is only optional at the time of online booking-in but is strongly encouraged by the BRCA to avoid clubs holding large amounts of physical cash at meetings.

The opinion from most in the room was that this does not benefit or "fit" with how Stock Car meetings are run. The proposal was voted on and rejected.

All proposed officials were accepted.

AOB:

NORA - none of the club members were able to attend the AGM. Alan Leighton BRCA PRO and newly elected Stock cars Section PRO has visited the Keighley track and offered some suggestions of how to minimise the noise output from the racing activity and may be able to support some of the noise reduction work from the BRCA PRO budget. It was believed that the Club are due to run some meetings before the end of the year for the local council to measure the sound levels.

WEMSA – No committee was agreed at the meeting and no volunteer for the Secretary position came forward. Concerns were raised on the subject of insurance cover and personal liability, these issues were discussed by Scott Grocock and Ricky Slater at length with Jim Spencer after the meeting had closed.

PRO – Alan the new section PRO outlined his plan to promote Stock Cars for the 2019 season with a refreshing passion. He said Stock cars has been undersold for a long time, has a lot to offer and he intends to promote and sell the section to a new audience. The Peterborough motor show was mentioned so Alan agreed to find out what is possible for the $1/8^{th}$ Stock cars at the event.

Meeting closed at 13:50.
