Supporting Notes:

- A full national calendar was held in 2021 with a total of 523 entrants across 8 events at an average of just over 65 entries per event. Our best ever season.
- The section has successfully migrated to full online entry and payment in 2021 which has simplified the booking in process and meeting preparation, however PayPal fees have increased as a result to £423.66 for the season.
- As confirmed last year, no income was made from the 2021 BRCA LSOR Handbook as those that supported the section in 2020 were given a free advert this year.
- The section has secured a new venue for our annual indoor event and has incurred costs in this financial year of £100.00 for venue hire and £125.30 on equipment costs (new loop and HDMI cables)
- Depreciable assets reduced in line with expectation and looks larger than normal due to use of £800.00 of trophies purchased but not used in 2020. This has also had a positive impact in the sections recorded profit for 2021 as we recover from our 2020 losses.
- As 2021 saw the return to racing following the 2020 season cancellation, incidental expenses (in addition to our usual running costs) increased as we replaced out of date, expired or damaged supplies. For example £90 on race numbers and £45 on a data sim card
- The section also contributed £275 to the 10 year Nene Valley Raceway celebrations held at the delayed R1 national in July

Junior drivers must have a replacement adult marshal. Failure to marshal will result in loss of qualiftq.

- Will have a Minimum width of 480mm, Maximum width, with tyres fitted of no more than 600mm when under full compression. It will also move freely in the size box.
- Shall have a minimum wheelbase of no less than 600mm (Axle Centres)
- When fully compressed should have a height no greater than 400mm.
- A bodyshell which covers the vehicles wheels must be securely fitted.
- Will contain a fuel tank that holds a maximum of 1000cc of fuel.
- Shall have a maximum engine of 30cc (1.8307 Cubic Inch)
